What is the PAW Award for HBU



What is Presence At Work (PAW)?

Q

 The Presence At Work Award (PAW) is based upon 3 separate components intended to reward and encourage employees to be Present At Work

Why is Presence At Work Important?

• Presence At Work is important because it is a Company Key Performance Indicator (KPI) which is measured by calculating a facility's Unplanned Absenteeism Rate (defined in the following slide)

What are the Three (3) Criteria for eligibility for the PAW Award?

- 1. Individual Award (\$1000) paid to eligible employees who have accumulated a total of 1850 Compensated Hours in the twelve months leading up to the PAW eligibility award date in October (October 20th, 2025)
 - Compensated Hours are defined as per EXHIBIT F (Part B) of the Profit-Sharing Plan:
 - Each layoff week counts as 40 hours credit towards an employee's 1850 compensated hours
 - Workers Compensation Hours are included as compensated hours
- 2. Facility Award (\$500) paid to eligible employees at a facility that achieved a 15% Year over Year reduction in Unplanned Absenteeism
- 3. Facility Award (\$250) paid to eligible employees at a facility that achieved a 5% (or below) Unplanned Absenteeism rate for the year

HBU - What is Unplanned Absenteeism?



What is Unplanned Absenteeism?



Unplanned absenteeism is defined as unplanned hours not worked by employees, who would normally be expected to be at work.

- Examples of Unplanned Absenteeism include:
 - > FMLA
 - Sickness and Accident Days
 - ➤ PAA Days called in without 24 hours notice
 - > Days an Employee is Absent that count towards an Attendance Occurrence (M-8)

How is Unplanned Absenteeism Calculated?

Unplanned Absenteeism is made up of the **total unplanned absenteeism hours** divided by **actual hours worked + all absent hours** for the facility

The annual unplanned rate is made up of all-associated hours at the facility for the year

Example of How Unplanned Absenteeism is Calculated?





What is Presence At Work (PAW)?

• The **Presence At Work Award (PAW)** is comprised of two individual metrics intended to **reward** and **encourage** SBU employees to be **Present At Work**.

What are the Two Criteria for eligibility for the PAW Award?

- 1. Individual Award (\$750) paid to eligible employees who have accumulated a total of 1850 Compensated Hours in the twelve months leading up to the PAW eligibility award date in October (October 20th, 2025)
 - Compensated Hours are defined as per EXHIBIT F (Part B) of the Profit-Sharing Plan:
 - Each layoff week counts as 40 hours credit towards an employee's 1850 compensated hours requirement
 - Workers Compensation Hours are included as compensated hours
- 2. Zero Unexcused Absences (\$1,000) paid to all active employees at a facility that achieved zero unexcused absences

SBU – What is an "Unexcused" Absence





What are "Unexcused" absences?

Unexcused Absences are defined as follows - when employee is absent from work for an unapproved reason that is not otherwise covered by the Collective Bargaining Agreement (CBA)

- Examples of Unexcused Absences include:
 - o Full day unpaid absences not covered under the CBA
 - eSTRS examples of unexcused time: OTHU, ILLU, ILFU, PERU, VACU

Examples of Excused Absences include:

- Eligible Vacation
- o FMLA
- Paid Casual Absences
- o Leave for Good Cause (Jury Duty, Bereavement, Military, Paid Parental Leave, etc.)
- o UBUS
- o CBUS

PAW Award Eligibility Guidelines for HBU & SBU



Eligible Employees

- o Employees on the active roll as of October 20, 2025
- o Temporary Layoff employees as of October 20, 2025
- Temporarily separated employees whose separation date is on or after July 23, 2025
- Temporarily separated employees as of October 20, 2025 coded LOA/MIL(subject to the aggregate maximum payment period for any individual employee of forty-eight (48) months)
- Employees on Pre-Retirement Leave (Dept. 1482)

Ineligible Employees

- Full-time probationary employees (FWA 1) and SBU probationary employees hired on or after June 22, 2025
- Temporary employees (FWA Codes 2, 3, and Q)
- All other inactive and separated employees
- O Any employee, who quits, is discharged on or prior to December 5, 2025, is not eligible



PAW Award Payment – HBU & SBU



Payment

The Presence At Work Award payment will be made by separate payment on Friday, December 5, 2025, based upon the employee's current pay method.



Overtime Recalculation Adjustment Payment

The Presence At Work Award payment is subject to an Overtime Recalculation payment. Employees who receive a PAW payment and had time and one-half pay during the eligibility period, will also receive an overtime recalculation payment with their regular payment on Friday, December 19, 2025.

Overtime Recalculation Example

Presence At Work Award Payment	\$1000
Total hours worked during eligibility period	2,301
Recalculation premium rate	\$1000/2,301 = \$.43
Premium hours worked at time and one half during qualifying year	373
Overtime recalculation amount to be paid	(\$.43 x 373) x 0.5 = \$160.39



UAW Savings Plan (UAWSP)



- Employees who want to defer need to make a separate election using bonus/award election button in their Merrill account
 - Elections are made via Merrill at www.benefits.ml.com or 1-800-483-SAVE.
- Election can be made any time during year, and it remains in effect for all current and future award payments unless employee changes it
- Bonus/award elections made last year which have not been changed, will remain in place for this
 payment
- Regular deferral rates continue for regular pay cycles.

Deductions

- UAW Union Dues deduction is 1.44% of the total payment
- Presence At Work Award payments are subject to flat 22% federal income tax, normal state and local taxes, FICA, Deferred Pay Plan contributions, child support arrearages and other legally required deductions.

PAW Award – Layoffs & Questions (HBU & SBU)



Employees on Layoff



Employees on layoff who receive a Presence At Work Award must report these earnings to their State Unemployment Agencies as follows:

- Michigan, Illinois, Indiana, and Ohio Do not report Presence At Work Award payment as earnings
- o For all other States, please refer to your State for reporting requirements
- FLSA Overtime Recalculation Payment must be reported as earnings for Benefit Week Ending December 20, 2025.
