Brothers and Sisters of Local 400, This is an election year and we all have very important decisions to make at the voting booth. Candidate campaign posters inhabit almost every street corner and political commercials flood our smart phones and televisions. The competition for your vote is in full motion.

This election year has new challenges. These come in the form of laws passed by states that have a more restrictive nature. In 2021, nineteen states enacted thirty-four laws restricting access to voting. These laws are wide ranging; from obstacles such as voting by mail, new voter ID requirements, and (in one state) it is now a crime to distribute water to voters waiting in long lines.

State legislators are continuing the voter restriction onslaught. 2022 has already seen its fair share of pre-filed bills (a bill which is submitted for introduction/ first reading before the legislative session begins. Pre-filed bills are introduced on the first day of the session) that restrict or burden the voter.

*"As of May 4, at least 34 bills with restrictive provisions are moving through 11 state legislatures. Overall, lawmakers in 39 states have considered at least 393 restrictive bills for the 2022 legislative session. Since the beginning of 2021, eighteen states have*

*passed thirty-four restrictive voting laws, which can disproportionately affect voters of color."*

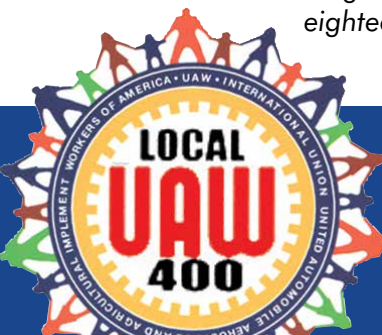

- October 24, 2022:** Second formal mail distribution of mail-in ballots distributed to additional voters.
- October 31, 2022, at 5:00 p.m. (ET):** Deadline by which members *MUST* be in good standing in order to have their vote counted in the Election.
- November 11, 2022:** Final date replacement ballots can be requested from the Election Vendor.
- November 18, 2022:** Last day by which members should place their ballots in the mail to best ensure receipt by **November 28, 2022 deadline.**

### ELECTION RULES FOR CONDUCT

1. Voting will be by secret ballot.
2. Voter must show positive identification and sign registration card at time of voting.
3. Each candidate will be allowed challengers during election and during counting. Challenger must be a member of UAW Local 400.
4. Challengers' names must be submitted to the Recording Secretary no later than Wednesday, October 26, 2022 by 12:00 noon.
5. All new members who have signed dues authorization forms from a participating employer and/or are current with their dues with UAW Local 400 are "members in good standing" and are eligible to vote.
6. A candidate shall have the right to submit her/his commonly known name as she/he wishes it to appear on the ballot.
7. Anyone wishing to withdraw must do so before 11:00 am Wednesday October 26, 2022 in writing. Any corrections, misspellings, etc. must also be received no later than this date.
8. Results will be tabulated by the Recording Secretary after the closing of the polls at the UAW Local 400 Hall, 50595 Mound Road, Utica, Michigan.
9. The Financial Secretary may be present at the polls at the time of voting for the purpose of guarding the records and books for which her/his office is responsible.
10. The Recording Secretary and his designated assistants shall remain neutral and not campaign for or favor any candidate.
11. Term of election: 3 years
12. Candidates may observe the printing of the ballots. Contact the Local 400 Recording Secretary, for time and date after Wednesday October 26, 2022.
13. All reasonable requests for absentee ballots will be met for members (on union or company business only) by contacting the Recording Secretary.
14. Campaign mailings request must be in writing delivered by regularly used or dependable means to the Recording Secretary. Local 400 will comply with any reasonable request by a candidate to distribute campaign literature at the candidate's expense.
15. Retired and Active members are eligible for candidacy and/or to vote in this election.





# A Problem, and a Solution

Those of us of a certain age will recall an often repeated theme from the 1960s – The Generation Gap. At the time, it seemed society was becoming unglued from all corners, with members of the “older” and “younger” generations often pitted against the other. The war in Vietnam, the struggle over civil rights, and the ever-widening gap between rich and poor were issues that persistently split Americans.

But concurrent with this division, a solidarity of sorts existed within each generation. Young men were subject to military conscription, which served as a great equalizer. Each individual faced the real possibility of fighting in a foreign land. From this shared potential fate rose a bond of brotherhood. Concerns over the nation’s future were shared most intensely among the young.

Flash forward to today. A level of shared solidarity, once ubiquitous, is all but absent among young people in our Local, and across our broader Union

membership. Today, enthusiasm for participating in our democratic process has all but evaporated, only to be replaced by myopia and personal selfishness.

Part of this is understandable. At present, younger members often grow frustrated at what they perceive as self-dealing and corruption among leadership, which breeds cynicism and distrust. Too often, younger members who do try to engage in the democratic process are rebuffed and even ridiculed. This was evidenced at the recent Union convention.

At this point in our history, this reality is especially troublesome. The industry which our Local and Union serve is pivotal to the economic health of our nation and world. The welfare of our environment demands a conversion to electric and other new forms of mobility. Clearly, this is no time for internal

squabbles.

Meeting the emerging challenges will require the undivided energies of all our members working alongside management. It will also necessitate all parties to rid themselves of parochial concerns over vested interests and personal power.

What will the solution look like? It will no doubt begin with a fair amount of introspection. The “old guard” that dominates leadership needs to ask itself where its responsibilities truly lie. What do they want their legacy to be?

The rank and file (usually the younger members) need to shed their cynicism and do likewise. A seamless dialogue must develop between the two groups.
