# COMPANY SELLS US OUT

## Local 400 will persevere and survive Romeo Engine closure

Dear Brothers and Sisters of Local 400, want to alleviate some of the concerns that have been brought to our attention since the ratification of the new UAW/Ford Collective Bargaining Agreement...

- YES... Romeo Engine is slated to close.
- YES... that will displace and inconvenience many of our members over the next few vears.
- YES... it takes a chunk out of Local 400's membership.
- NO... this is not the end of Local 400.

First, to Romeo Engine members... I am as angry and as disappointed in this new agreement as the rest of you (not just because REP is slated to close). I am as angry and disappointed in the UAW leadership that has cheated our members out of our hard-earned dues money. I hope and expect all involved in any of this deception and theft are prosecuted, convicted, and are thrown out of the UAW with violent force.

And... I am angry and disappointed with Ford Motor Company for their incredible greed that would drive them to close any facilities while making their billions of dollars. But the fact is, the membership voted to ratify this agreement and now we have to take care of our people.

None of the officers or Bargaining Committee from REP will stop fighting for anything that may sustain the plant

and our members. If this endeavor is unsuccessful, however, we must focus on our members and what will best suit them and their families for their future. We have to remain vigilant in what we as Local 400 leaders have always done – stand for our Brothers and Sisters.

Our strength and resolve does not depend on those at the top of the UAW. I ask that those who took the oath to serve and defend our great organization band with us to practice what we preach and protect our UAW family by doing what is right. Our strength and resolve comes from what we have always done - grow tighter and stronger together as Local 400 Brothers and Sisters when faced with adversity.

As much as the press and outside influences like to think so, our Union doesn't derive its power from the top. It draws the power from the hard-working people on the floor of our facilities with grit and determination for justice and equality. With you by our side, we will rebuild our greatness from within.

As for UAW Local 400, we are not going anywhere anytime soon. We still have almost 2.000 active members, even without the members at REP. There are still over 4.000 retired members who belong to our family. We may have to make some changes over the next few years to maintain our stability and growth, but I assure you that your officers will do what it takes to keep UAW Local 400 viable for many years to come.

In the meantime, it will be business as usual in the sense that we will continue to work with all of the committees of all of our facilities in securing new work and maintaining current work, negotiating fair and beneficial Collective Bargaining Agreements, fighting for better safety

standards, and protecting our members from anyone who threatens our family. We will continue to be a presence in our communities through the giving of our time and support to whomever we can. Please remember that no matter how frustrated you get with your Chairperson, Steward, Bargaining Rep., or any Union official; the UAW was built with a structure to withstand. That structure requires a firm foundation and that foundation is you!

Do not let the outside influences crack that foundation, whether it be the press, politicians, unscrupulous leadership, the company, or anything else. As long as we tighten the ranks of our foundation in SOLIDARITY, and as long as we do not let those outside influences divide us as working class Brothers and Sisters, then our UAW and our way of life that was fought for - with the blood, sweat, and tears of generations before us and is still fought for today – can never be beaten.



On Thursday, September 12, 2019, we, once again, had a wonderful day to celebrate our retirees. It was a fantastic turnout for a beautiful






Ballots will be counted immediately after the closing of the polls on Election Day.

#### **RULES FOR CONDUCT OF THE ELECTION**

- 1. Voting will be by secret ballot.
- 2. Voter must show positive identification and sign registration card at time of voting.
- 3. Each candidate will be allowed challengers during election and during counting.
  - Challenger must be a member of UAW Local 400.
- 4. Challengers' names must be submitted to the Recording Secretary no later than Monday, January 13, 2020 by 12:00 noon.
- 5. All new members who have signed dues authorization forms from a participating employer and/or are current with their dues with UAW Local 400 are "members in good standing" and are eligible to vote.
- 6. A candidate shall have the right to submit her/his commonly known name as she/he wishes it to appear on the ballot.
- 7. Anyone wishing to withdraw must do so before 11:00 am Friday, January 3, 2020 in writing and any corrections, misspellings, etc. must be received no later than this date also.
- 8. Results will be tabulated by the Recording Secretary after the closing of the polls, at the UAW Local 400 Hall, 50595 Mound Road, Utica, Michigan.
- 9. The Financial Secretary may be present at the polls at the time of voting for the purpose of guarding the records and books for which her/his office is responsible.
- 10. The Recording Secretary and his designated assistants shall remain neutral and not campaign for or favor any candidate.
- 11. Term of election: until two months before the next general election.
- 12. Candidates may observe the printing of the ballots. Contact the Local 400 Recording Secretary, for time and date after Monday, January 6, 2020.
- 13. All reasonable requests for absentee ballots will be met for members (on union or company business only) by contacting the Recording Secretary.
- 14. Campaign mailings request must be in writing delivered by regularly used or dependable means to the Recording Secretary. Local 400 will comply with any reasonable request by a candidate to distribute campaign literature at the candidate's expense.
- 15. Retired members may vote in this election, as well as active members.


