

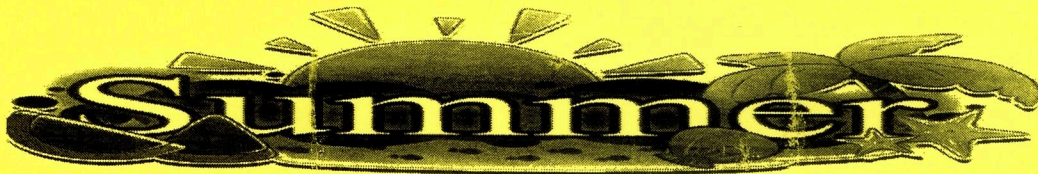

NEW BYLAW PROPOSALS

READ AT THE SUNDAY, JUNE 26, 2022

GENERAL MEMBERSHIP MEETING

New By-Law Proposal #1

Added to Article XVI

Shop Stewards

1. *Whenever there is a decrease of employment that would result in a reduction of Chief Stewards, the Chief Steward with least number of constituents shall be eliminated. It is understood that no shift will be without representation on their shift.*
2. *The Local Bargaining Committee shall determine and establish the method for representing members of the eliminated Chief Stewards District.*
3. *Whenever there is an increase of manpower that would result in the increase of an additional Chief Steward within the same term, the Chief Steward most recently eliminated shall be restored as the Chief Steward without an election being required. When two or more Chief Stewards have been eliminated, the one with the longest service shall be restored first, with ties to be broken by the last four of their social security number (consistent with current practices).*
4. *When any additional Chief Stewards are needed over and above those elected at the last General Local Election, the Shop Committee will redistrict. The Local President will appoint a temporary Chief Steward from the respective area, and a new Chief Steward will be elected by the from the new district as soon as possible.*

New By-Law Proposal #2

Add to Article XVI

Shop Stewards

- F. *Whenever there is a decrease in employment that would result in a reduction of Chief Stewards, The Shop Committee will decide the shift and Chief Steward that will be eliminated. In case of a tie, the President of the Local is the deciding vote.*
- G. *The Local Shop Committee shall determine and establish the method for representing members of the eliminated Chief Stewards District.*
- H. *When there is an increase in employment and a Steward needs to added. The last Steward that was eliminated due to redistricting, will be added first, with No election if it is within their term. If more than one Steward was eliminated, it will be in sequence from last one eliminated, to first one eliminated, with No election, if it is during their term.*
- I. *When any additional Chiefs Stewards are needed over and above those elected at the last General Local Election, the Shop Committee will redistrict and a Special Election will be held the following month.*
- J. *If any redistricting involves a Skilled Trades Steward being cut, and employment levels keep him/her from being reinstated as a Steward during their term. Skilled Trades will have the opportunity to run in the General Election in the other districts and divisions in the plant on that shift.*
