




#### **ELIGIBILITY** ^


TAP provides eligible works with financial assistance to take job-related, degree seeking courses at nationally and regionally accredited institutions. In addition, effective January 1, 2014, workers make take approved Labor Study courses.

Educational institutions must be preapproved by the TAP administration to be eligible. Payments for tuition and appropriate fees will be made directly to the educational institution, or if the institution does not accept vouchers, will be made to the employee as a reimbursement for eligible out-of-pocket expenditures.


